The goal is to tie the everyday environmental and outdoor concerns of Minnesotans to local and state public policy decisions. The debut issue focuses on stories about Minnesota water, with citizens talking about fishing and kayaking, and articles on drinking water safety and citizen water stewardship efforts lead by Minnesota Waters. Also included is a summary of 2007 state legislation on Great Lakes water use, energy efficiency and renewables, climate change, and recycling of consumer electronics.
