This item comes from Zak Pagel of Clean Water Action: The U.S. Environmental Protection Agency (EPA) is accepting public comments until January 21 on a policy that will determine which rivers, lakes, streams and wetlands are fully protected. This new guidance offer "no protection" for our critical water resources and tells government officials to ignore not only the benefits of

This could mean increased flooding, dirtier and more costly drinking water and more pollution problems in waters across the country. More than 100 people showed up for the Big Stone II Administrative Hearing in Ortonville on January 10th. According to Patrick Moore, intelligent and passionate anti-Big Stone II testimony was presented by the Willmar League of Women Voters, Doctors, Lawyers, Teachers, Nuns, Farmers, Native Americans, Business Owners, Students, etc. A "People's Press Conference" was held before the hearing.

Here are some interesting items in the news in the last week or so:

- Minnesota is joining a coalition of 16 other states to sue the Environmental Protection Agency to preserve state's ability to regulate vehicle emissions. The lawsuit came out of California where EPA denied the state's request to set higher tailpipe emissions standards than that of the federal government. California wants to reduce vehicle greenhouse gas emissions by 30% by 2016. California contends it can obtain a waiver from the federal government to set its own standards. According to MN Attorney General Lori Swanson, Minnesota hasn't adopted the California standards but filed the petition in order to preserve the state's ability to do so. (Minnesota Public Radio)
- The eighty groups with the Minnesota Environmental Partnership (MEP) have come up with a legislative agenda. Here are some of the causes they will be advocating in 2008:
 - A quick passage of the great outdoors and heritage amendment a constitutional amendment dedicating sales tax revenue to outdoor projects and the arts,
 - The legislature to authorize a cap-and-trade system designed to reduce carbon emissions,
 - More funds for transportation, in particular transit projects (Minnesota Public Radio)
- Major electronic manufactures including Panasonic, Sharp and Toshiba have come together to comply with Minnesota's new electronic recycling law. The "Electronic Recycling Act" law signed by Governor Pawlenty in 2007 requires manufactures of video display devices like televisions, computer monitors and laptop computers to recycle 60% of the volume of their sales for two years and than 80%. The three electronic companies formed Electronic Manufactures Recycling Management Company to operate a collection and recycling program in the state "and beyond." According to the Minnesota Monitor, "Minnesota has more than 150 other registered collection sites for consumer electronics, which is good news as Minnesota also has an estimated 19 million pounds of electronic waste."

A Minnesota woman offered the owner of a cabin in Eagles Next Township a \$1,000 to let a
bear and her two cubs continue hibernating for the winter. She was afraid moving the bears
to a wildlife sanctuary would be a death sentence because they wouldn't fit in with the bears
born or raised in captivity. The DNR has decided to move them a wildlife sanctuary in
Michigan.
