Reducing nutrient levels is the focus of a water quality study for Crystal Lake in Blue Earth County in south-central Minnesota. Excess nutrients in the lake are causing algal blooms and having a negative impact on recreational opportunities. The Minnesota Pollution Control Agency (MPCA) invites the public to submit comments on the report of the Crystal Lake water quality study through Sept. 26, 2012. The agency also encourages local residents to attend an open house on the study on Monday, Sept. 10, from 5:00-7:30 p.m. at Robinson Park in Lake Crystal.

Expiring Conservation Reserve Program Options

Landowners evaluating options for expiring Conservation Reserve Program (CRP) acres should consider opportunities to keep sensitive acres in grasslands or perennial vegetation that preserve soil, water, and wildlife resources. Many CRP lands border ditches, waterways, streams or rivers that could be eligible for federal, state or local buffer programs that would offer continued protection to these sensitive areas. In the last 20 years, over 1 million acres in Minnesota have been enrolled in CRP. The United States Department of Agriculture (USDA) program has provided a source of income to landowners with sensitive lands while protecting and preserving soil, water and wildlife resources. All current contracts expire on September 30 of the last year of the contract.

A SIP OF SCIENCE - The Surprising Life of Native Mussels

Freshwater mussels are one of the most endangered animal groups in North America, but the role of these mollusks in freshwater ecosystems, including our own Mississippi River, is vital to the survival of other animals and to the stability of the food chain. Freshwater mussels improve water quality in rivers and streams, allowing greater light penetration for algae and other organisms to grow, and they act as excellent indicators of environmental changes.
