

### **Watershed wide, Citizen-Led, Water Quality Action Meeting Scheduled for March 29 in Red Wing**

The public is invited to attend a watershed wide, citizen-led conversation on water quality issues facing the Minnesota and Mississippi Rivers to be held on Thursday, March 29th at the St. James Hotel located at 406 Main street in Red Wing, MN. The event is free, but advanced registration is required.

The conversation is being sponsored by a wide range of grassroots citizen groups, farm groups, the Minnesota Pollution Control Agency and InCommons. The purpose of the meeting is to explore how citizens, businesses and government can share leadership by collaborating to restore water quality through specific on the ground projects and cross sector initiatives.

The meeting will feature a meal and round table discussions facilitated by **InCommons** - a community-based initiative that connects Minnesotans to share tools, knowledge and resources to address complicated problems.

The Red Wing dialogue will build on the success of other round table discussions recently held in Mankato and Owatonna. More than 200 different people have attended these discussions where farmers, environmental advocates, government agency workers and recreational users of the river sit at the same table to discuss the issues and seek common ground.

This third dialogue will focus on concrete action steps that all these groups can take together. The evening meal will be the final segment of a day-long event designed for citizens to connect with Minnesota and Mississippi River water quality issues. ### **A message from Patrick Moore of CURE**

CURE is opposed to the private ownership of public officials. As our region buried [Senator Gary Kubly](#) yesterday, we reflected upon the fact that he was a man of unquestionable integrity. This is why CURE has renamed our annual award for public service as [The Kubly Good Government Award](#). In many ways, Kubly's quiet and diligent manner was a reflection of his constituents -- the hard working and unassuming people of the Upper Minnesota River Watershed.

Going forward from Sen. Kubly's funeral, however, it is becoming more difficult for local public officials to stand up to the power of out-of-state corporations.

Do you remember the granite outcrop site along the Minnesota River at Ortonville, MN that local [citizens are fighting to protect](#) from an out of state mining company?

This past Tuesday we witnessed as [Strata Corporation](#) flew a private jet to Ortonville in order to take Big Stone County Commissioners on a tour of the proposed aggregate mining project site. Commissioners were ferried to the outcrops, two at a time, in an attempt to circumvent the Minnesota Open Meeting Law.

Although Strata Corporation's permit request is still before the commission, midway in the process, Big Stone County Commissioners chose to leave interested Big Stone County citizens behind, playing a one sided game with Strata at bat and no one in the field. No media and no local citizens were allowed to accompany the commissioners as Strata pitched their desperately convoluted and shockingly brazen plan to mine these precious outcrops amidst local homes, rare habitat, and a new recreational bike trail. Later, the Strata officials lunched with the Big Stone County Commission Chair.

What was Strata's message?

Strata has hired the [biggest and best law firm that money can buy](#) to assure a permit victory. If the Big Stone County commissioners vote to deny the permit, Strata will very likely sue the county. Strata may also lobby Ortonville Township officials in an attempt to reverse the moratorium passed by the Town Board to protect the outcrop.

Strata is posturing. Strata aims to win. Strata intends to have the Big Stone County Commission working for them and not for the people of Big Stone County. Strata does not intend to let the majority of county citizens who oppose this quarry get in the way of a 130 year plan to blast, crush, and ship out the wealth of Big Stone County's most rare and beautiful landscape.

CURE is establishing an emergency fund to help the local citizens of Big Stone County fight back and help convince the County Commissioners to support the Ortonville Township moratorium by denying Strata's conditional use permit. We have exhausted the small amount of money we had to help coalesce and give voice to local opposition. Now that we are up against Corporate Jets and Hired Gunns -- we will need your help to sustain this effort.

**MPCA to recognize advisers on Mississippi, Minnesota River water quality projects**

St. Paul, Minn. — The Minnesota Pollution Control Agency plans to host events recognizing stakeholders and advisers who have participated in the development of two major Total Maximum Daily Load (TMDL) water quality projects, for the South Metro Mississippi River and the Minnesota River.

On Wednesday, March 21, members of the Minnesota River Turbidity TMDL Advisory Committee and Sediment Reduction Advisory Committee are invited to a recognition event and TMDL update from 10 a.m. to 1 p.m., including lunch, at the Redwood Area Community Center in Redwood Falls. After lunch there will be optional small group conversation on specific aspects of the TMDL report.

On Thursday, March 29, from 10 a.m. to 1 p.m., members of the South Metro Mississippi Stakeholder Advisory Committee and Science Advisory Panel are invited to a recognition event and TMDL update, including lunch, at the St. James Hotel in Red Wing.

Bob Finley, regional watershed manager for the MPCA, will provide an overview of the draft reports at the March 21 and March 29 events. Advisory group members are welcome to attend either meeting if they are unable to attend their group meeting. An RSVP is needed to determine the number for lunch.

Details will be announced later about additional meetings to be scheduled in St. Paul and Mankato. A meeting focusing on urban stormwater aspects of the TMDLs has been scheduled for April 19. It will be 9-11 a.m. at the MPCA St. Paul office, 520 Lafayette Rd. N. Groups may also request presentations by MPCA staff.

The TMDL reports focus on turbid water caused primarily by sediment. Turbidity is caused by suspended and dissolved matter, such as clay, silt, organic matter, and algae. High turbidity results in poor water quality for aquatic habitat, recreation, industrial use, and human consumption.

The reports are on public notice through April 27. During this period, comments become part of the review-and-approval process. The MPCA prepares responses to comments, and may amend the draft reports if necessary. The reports are available on the agency's [South Metro Mississippi Turbidity Impairment webpage](#) and the [Minnesota River Turbidity Impairment webpage](#).

Also on March 29 the Lake Pepin Legacy Alliance will host two related events at the St. James Hotel:

1. The first, from 1:00-4:30 p.m., is a workshop focused on providing comment on the South Metro Mississippi TMDL.

### **MN DNR Stream Habitat Program - 2012 Workshop offerings**

Registration is open for the following two workshops:

#### **The Science of Healthy Waters**

This new series, The Science of Healthy Waters, is designed for anyone involved in watershed issues including water quality (rivers, lakes, wetlands), aquatic and terrestrial habitat, land use, wetlands, and flooding. This series will present: a) the science underlying integrative, system-based watershed management, b) the problems, issues, and barriers hampering our ability to protect and restore watershed health and c) alternative approaches for accomplishing goals of clean water, improved fish and wildlife habitat and reduction of flood damages and erosion. Each workshop addresses a specific topic related to stream health.

#### **The Science of Healthy Waters: The Dam Dilemma \*New workshop\***

This workshop will unpack the science and implications involving dams in terms of: 1) effects on connectivity, hydrology, geomorphology, water quality, and aquatic habitat, 2) societal and ecological implications of these structures and 3) the challenges, benefits and design approaches of dam removal, dam modification, and by-pass fishways.

**The Science of Healthy Waters: The Ditching Dilemma \*New in 2011\***

This workshop unpacks the science and implications of ditching in terms of: 1) effects on hydrology, geomorphology, water quality, and aquatic habitat, 2) societal and ecological implications of these practices, and 3) alternative design concepts and approaches that work towards accomplishing sustainable agricultural goals while improving water quality and restoring channel stability and ecological health.

**Director of Development**

Open Arms is the only nonprofit organization in Minnesota that cooks and delivers free meals specifically tailored to meet the nutritional needs of individuals living with HIV/AIDS, MS, ALS, cancer and more than 60 other diseases. This organization also works with communities in Sub-Saharan Africa, providing food and technical assistance for people living with and affected by HIV/AIDS.

A candidate for this leadership position will need to be a seasoned professional with a combination of fundraising and communications experience along with a strong passion for the Open Arms mission—providing resources that support the nutritional needs for individuals with compromised immune systems or chronic illness—and their families.

The Director of Development is a new position for this organization, but the development function is not new and various components have been operationalized throughout the organization's history. The Director will report to the Executive Director (E.D.)—who will also be new to their role and will be named prior to interviews for this role. **District Technician**

Rice Soil and Water Conservation District is hiring a District Technician. This position is under the general supervision of the District Manager and performs a variety of technical and educational work to fulfill the soil erosion and sediment control needs of landowners in Rice County. The primary responsibility will be to promote and provide technical assistance for wetland restorations and grass based conservation programs, assess the erosion control needs on private lands and survey and design conservation practices for implementation.

#### Duties and Responsibilities

- Promote the enrollment of conservation easements into programs such as the Conservation Reserve Program (CRP), and the Reinvest in Minnesota (RIM) program.
- Provide technical assistance for wetland restorations and grass-based conservation.
- Assist landowners with the enrollment of conservation easements.
- Identify conservation practices needed on agricultural lands and assist landowners in the survey and design of a variety of practices through the use of state and federal programs.
- Coordinate the use and delivery of the no-till drill.
- Coordinate the delivery of the Cooperative Weed Management Area grant.
- Enter all state funded grant projects into the E-Link database.
- Submit reports to the SWCD manager on the progress of all assigned programs.
- Other duties as assigned by the District Manager.

#### Application Procedure:

Applicants must submit a completed Rice SWCD application, resume, and cover letter for employment. Applications may be printed from our website at <http://www.riceswcd.org> or can be picked up at 1810 30th St. NW, Faribault, MN 55021 or by calling 507-332-5408. Applications will be evaluated based on the information supplied in the resume, cover letter, and SWCD application to determine if they meet the minimum job qualifications. A maximum of 5 applicants will be selected by the Rice SWCD personnel committee for interviews, but may be less depending on the number of qualified applicants. The final candidate selected will not be hired until the Rice SWCD board takes action at the next available board meeting. The candidate selected will be subject to a federal background check upon hiring.

#### **Big Stone SWCD Intern Position**

The Big Stone Soil and Water Conservation District is hiring an intern position from May through August approximately for \$10.00 per hour. This position is a seasonal position under direct supervision of the Soil and Water Conservation District (SWCD) District Technician and the Big Stone SWCD Board of Supervisors. The seasonal position is primarily responsible for implementing projects in regard to weed management in Big Stone County. This is a multi-pronged approach focused on our newest invasive weeds that will include: education, documentation, treatment, and re-seeding with local eco-type native seed sources. Education includes organizing workshops and tours. This position will monitor, treat, and document the locations of invasive species infestations with a GPS, using Arc Pad. Weed identification field guides, herbicide, spraying equipment, and local-ecotype seed will be purchased and distributed to landowners. Operation of machinery and farming background or experience preferred. The work hours are 8:00 to 4:30 Monday through Friday. The hours may vary also based on what work is available to be completed. This position may also seed some native grass seeding projects as well as other duties as assigned. This position is funded through a grant and has the possibility of being available for more than one season. The position will also include time under the direction of the Big Stone SWCD as field work requires.

#### MINIMUM QUALIFICATIONS:

- Strong interpersonal, written and public speaking communication skills and capacity to work with a wide variety of people.
- Must be physically able and willing to work in varied terrain and weather conditions, capable of lifting 70 lbs.
- Must have a valid driver's license.
- Be able to pass the MN Certified Pesticide Applicator Test within 3 weeks of hiring.

- Must be willing to organize workshops and tours, give presentations, prepare annual reports, and develop educational materials and brochures.
- Farm, rural, agribusiness background preferred. Experience with machinery helpful.
- Ability to calculate proper herbicide application rates, operate computers and GIS, Arc Pad or GPS devices, comprehend maps and general rules and information.
- Self motivated, able to work with a minimum of supervision.
- Agronomy, Agricultural Business, Natural Resources, Biology or related background or education or training helpful.
- Completed one semesters of plant identification or similar education/training preferred.
- Ability to maintain a high degree of professionalism in representing Big Stone SWCD at public events and in the field with private landowners and general public.
- Willing to work long days in the outdoors, if conditions are good.
