**Citizen Led Urban Pollution Reduction Project Expands to Upper Minnesota River Watershed** Clean Up the Minnesota River movement founder Scott Sparlin to come to Montevideo Tuesday, March 22 to talk about Award winning Community Clean Up program.

Citizens concerned with polluted runoff originating from the gutters and lawns of small towns in the Upper Minnesota River Watershed are invited to come and learn about what they can do from the founder of the clean up the Minnesota River movement, Scott Sparlin of New Ulm on Tuesday, March 22 at 7 p.m. at the CURE office 117 South First Street, Montevideo MN.

"Early spring and late fall give us an opportunity to prevent pollution from making its way into our surface water," Sparlin said. According to Sparlin, excess phosphorus and nitrogen are a water quality problem in our rivers, lakes and streams. "There are also ways to prevent this type of urban runoff year round and we want people to come to find out they can do."

Sparlin will explain the award winning **Community Clean Ups for Water Quality** program that can be carried out by organizations and civic groups as well as individuals. According to Sparlin, every citizen can play a first hand role in pollution prevention with this program. **Bill would exempt ethanol plants from one environmental review** by <u>Stephanie Hemphill</u>, Minnesota Public Radio (March 8, 2011)

St. Paul, Minn. — A bill making its way through the Minnesota Legislature would exempt ethanol plants from an environmental review requirement.

Under current law, if an ethanol plant wants to expand production more than 5 million gallons a year, there must be an Environmental Assessment Worksheet.

Rep. Bob Gunther, R-Fairmont, said this kind of review is not necessary.

"This is just for an expansion of like 15 million gallons, there is no environmental impact for that extra 15 million gallons," Gunther said. "It would need more water, but the water is getting to be less and less of a problem."

But Gary Botzek, a lobbyist with the Minnesota Environmental Partnership, said these kinds of reviews are useful.

"It does provide some of the needed information to avoid some of the potential pitfalls as it relates to contamination and/or pollution down the road," Botzek said.

The Minnesota Pollution Control Agency has been working intensively with ethanol plants to help them reduce their permit violations. In 2009, the agency said the ethanol industry only complied with instructions half the time or less.

The measure cleared the House Agriculture Committee. Botzek said his group will continue to oppose the change in law when it next appears in the House Environment Committee.

#### Flood Preparation: Move Items that could become Hazardous Wastes

The Minnesota Pollution Control Agency (MPCA) urges home and business owners to think about potential spring flooding and to walk through the house, garage and sheds to gather up unwanted or expired household products that could become hazardous waste if flooded.

Take batteries, solvents, paints, paint thinners, pesticides, household cleaners and other chemicals that you no longer need to your county's household hazardous waste facility. Store products you plan to keep in a place that is not likely to be flooded. After the flood, any products exposed to floodwaters must be considered contaminated and will need to be disposed of properly. #### Sr. Community Prevention Consultant

This position is responsible for the design, development, implementation and evaluation of one or more evidence-based prevention technical assistance, training, and consulting programs related to food policy and healthy food access. The individual will have primary accountability for leading teams, coordinating and collaborating with staff in the Public and Health Affairs Division and colleagues in external organizations, meeting project objectives and contributing to the improvement of health outcomes. Projects often involve significant work with external entities, requiring a high-level of expertise in developing and maintaining strong business relationships. This position includes accountability for identifying issues, barriers and/or opportunities across projects and working with colleagues to address those effectively. In addition, this position will participate in the coaching, mentoring and training employees.

The primary functions of this role are developing services and products for clients and providing direct technical assistance, training and one-on-one consultation to clients. The technical assistance, training, and consulting is on policy, systems and environmental change best practices for achieving health outcomes to reduce obesity and tobacco use and address health equity. Specifically, this role will provide content expertise around food policy and healthy food access.

The person in this position is also responsible for leading multiple Prevention Minnesota projects aimed at reducing tobacco use and obesity rates in Minnesota communities. This involves planning, implementing, and evaluating multi-faceted projects in collaboration with community stakeholders.

#### SOME OF THE DAY TO DAY PROJECTS WILL CONSIST OF:

Working with public health advocates, community based organizations, community leaders and other stakeholders to create community health change through developing and implementing policy, systems and environmental public health strategies. This work will be conducted by providing tailored highly interactive trainings, useful planning tools and in-depth technical assistance and consultation utilizing best practices and lessons learned from extensive experience working on successful policy, systems and environmental change campaigns in communities across the country. This position reports to the Manager of Community Prevention Consulting.

#### Accountabilities:

1. Lead planning efforts to develop multiple prevention technical assistance and consulting programs to help address our client's health goals and objectives.

2. Deliver technical assistance, training, and consultation to client's to help them meet their community health goals and objectives.

3. Contribute to sales strategy by identifying sales opportunities, building strategic relationships, assisting in the development of

8. Proactively and reactively consult and problem-solve with clients on the implementation of recommended strategies.

9. Develop and enhance relationships so client's will extend current work or hire us for additional projects.

10. Evaluate effectiveness of community prevention strategies in order to provide strategic health improvement consultation that shapes future health improvement efforts.

# Environmental/Conservational Articles:

<u>EPA to strengthen invasive species defense on ships</u> (Minnesota Public Radio). Conservation groups say they've reached an agreement with the Environmental Protection Agency that will lead to new restrictions on invasive plants and animals in the ballast water of ships traveling the Great Lakes.

<u>Legislature closer to repealing ban on new coal plants</u> (Minneapolis Star Tribune). House and Senate committees sent legislation to the floor of each chamber. Environmentalists say a repeal would bring increased greenhouse gas emissions.

<u>U.S. Chamber of Commerce singles out stalled energy projects</u> (St. Paul Pioneer Press). The U.S. Chamber of Commerce released a study Thursday that identified five stalled energy projects in Minnesota that it said could contribute \$12.8 billion in economic output and 21,100 jobs a year if they were green-lighted over the objections of local citizens and environmentalists.

Wrong decision on study bears (Minneapolis Star Tribune). The DNR's decision not to extend protection for study bears is a black eye for the state - and for hunters.

<u>GOP looks to legacy amendment funds in budget fix</u> (Minnesota Public Radio). For months, Republican legislative leaders have said that they intend to balance the state's budget without raising taxes.

<u>Study: Pharmaceutical chemicals widespread in Minn. streams</u> (Minnesota Public Radio). Potentially harmful chemicals and pharmaceuticals are widespread in Minnesota streams, state scientists found in a new study.

Embracing the local: MN Farm to School programs see dramatic increase (MN News Connection). Minnesota schools are embracing locally produced food, according to a new report.

<u>Pawlenty's flip-flop on energy and environment -- and what's ahead for our state</u> (MinnPost). It was toward the end of the state House Committee meeting on March 3, 2011, that Rep. Joe Atkins, DFL-Inver Grove Heights, directed everyone's attention to the screen.

<u>No compromise reached on lottery-funded project list</u> (Minnesota Public Radio). An advisory group that evaluates proposals for projects to fund with lottery money has defied the request of two key legislators to drop some of its recommendations.
