during the festival were thought provoking and it was heartening to see all the video entries from the youth. Of the top ten entries (out of 23 submitted), eight were from students in the Montevideo area.



State Senator Dennis Fredrickson and State Representative Terry Morrow spoke at the recent MN River Board meeting about water issues including the Clean Water Legacy Funding, TMDLs, drainage and individual watershed project. They related how the emphasis on improving our water quality has seen a major change in the last 10 to 15 years.

The Lower Minnesota River Watershed District is proposing a MAWD (Minnesota Association of Watershed Districts) Resolution for a "River Basin Approach for Water Management Planning and Implementation in the MN River Basin." They want the State Legislature to establish by statute a Minnesota River basin Commission to:

1. Protect, preserve, and use natural surface and groundwater storage and retention systems,
2. Maximize benefits of public capital expenditures needed to correct flooding and water quality problems,
3. Identify and plan for means to effectively protect and improve surface and groundwater quality,
4. Establish more uniform policies and official controls for surface and groundwater management,
5. Prevent erosion of soil and associated pollutants into surface water systems,
6. Promote groundwater recharge,
7. Protect and enhance fish and wildlife habitat,
8. Secure other benefits associated with the sustainable use and management of surface and groundwater resources,
9. Promote coordination and cooperation among basin water management organizations and other stakeholders involved in the completion of Total Maximum Daily Load studies for impaired waters in the Minnesota River Watershed.

Mankato and North Mankato area have kicked off an urban reforestation initiative called ONE MILLION TREES BY 2020. The benefits of reforestation include: Beautification \* Carbon sequestration \* Hardwood and biomass production \* Wildlife habitat \* Summer cooling \* Groundwater recharge and soil stabilization \* Fuel savings (no mowing required) \* Recycling of auto tailpipe emissions \* Noise abatement. They are looking contributions including seedlings, along with individuals, youth, civic and school groups to volunteer to plant seedlings in April. They also need people to supervise volunteers and groups in plantings and people to organize and coordinate planting.
