Some New Year Resolutions to think about in 2008:

- Be informed with what is going on in the Minnesota River Watershed by attending local government meetings, joining a conservation organization or participating in an area event.
- Become a citizen volunteer by monitoring your favorite lake, river or wetland. Many
 watershed groups have citizen monitoring programs or contact the Minnesota Pollution
 Control Agency and Minnesota Waters.
- Take part in a community clean-up. Throughout the MN River Watershed you will find groups like CURE, Friends of the MN Valley and Mankato Paddling Club sponsoring river-related clean-ups.
- Put in a rain garden or rain barrel to help filter runoff from your house and other buildings before it enters a stormwater system or water body like a river, lake and wetland.
- Visit a business that is producing a local product. A number of places come to mind including Moonstone Farms (beef), Morgan Creek Vineyard, St. Peter Food Co-op, and Earthrise Farms.
- Paddle your favorite river or try a new one. The Minnesota River Watershed features a
 vast diversity of streams to paddle, whether it is a fast one like the Hawk Creek or a more
 leisure float on the Chippewa River.

The Minnesota River Watershed Alliance (Watershed Alliance) is an organized network of citizens, public agencies, and private organizations dedicated to communicating the benefits of an ecology healthy Minnesota River Watershed to others and are actively working towards its improvement and protection.
