MPCA now accepting proposals for watershed sampling grants in Upper Mississippi and Minnesota river basins

The RFP process for Watershed Pollutant Load Monitoring Network's (WPLMN) sampling grants is now open. Grants under this program are financed through the Minnesota Clean Water Fund established by the Legacy Amendment. The MPCA will award up to \$300,000 in one-year grant contracts through a competitive process. All proposals must be submitted through the SWIFT e-supplier portal and must be received no later than Sept. 19, 2014. Proposals received after this deadline will not be considered. The privacy objective of the WPLMN is to obtain spatial and long-term pollutant load information from Minnesota's rivers and streams. This RFP seeks to local partners to collect water quality data at select sites in the Minnesota River and Upper Mississippi River Basins. Water quality samples will be collected across a full range of flow conditions with greatest emphasis given to periods of moderate and high flow. Water quality data will be paired with stream flow information to yield estimates of containment loading from within a watershed.

Eligible entities include: SWCD's; watershed districts; regional planning organizations; watershed management organizations; local government units such as counties, cities, townships, and lake improvement districts; regional government groups; joint powers boards; Minnesota colleges and universities; non-profit organizations; and Native American tribal governments.

Yellow Medicine launches '1 watershed 1 plan'

The core team for the Yellow Medicine River One Watershed One Plan pilot project met Aug. 5 in Marshall. Doug Thomas and Melissa Gilbert of BWSR led discussion in separate meetings with state agency and local staff. Dave Sill of BWSR located in Marshall is the contact. The Yellow Medicine Watershed District covers a four-county area that includes Lac qui Parle, Lincoln, Lyon, and Yellow Medicine counties.

Cost share program makes organic certification more affordable

Minnesota organic farmers and processors can apply for a rebate of up to 75% of the cost of their organic certification. The MDA is accepting applications for the Minnesota Organic Cost Share Program from now until Oct. 31, 2014. Organic certification is a third-party verification system assuming consumers the organic products they buy are produced in accordance with federal organic regulations. Organic operations must follow National Organic Standards and are monitored through review of their records and on-site inspections at least once a year. "This program is designed to make organic certification more affordable," said program administrator Meg Moynihan. "The last time we offered it, 526 organic operations received rebates. There are now many more organic farms and handlers in Minnesota, so we hop to receive an even larger number of applications this year," she added. Operations that received certification (or had ongoing certification) between Oct. 1, 2013 and Sept. 30, 2014 are eligible for reimbursement of up to 75 percent of certification-related costs with a maximum of \$750 per category (crop, livestock, processing/handling, wild harvest). In an equally short time their cultural imprint was reduced in essence to a handful of place-names appearing on maps. Brief Description: Please join us for our "two-part trail tour" presented by Scott Kudelka, Minneopa Area Naturalist. The two programs, one in August and one in September, will take place out on the Traverse des Sioux trails and will teach participants about the two very different landscapes on either side of the Minnesota River - the Prairie and the Big Woods. During the Prairie tour we will learn how prior to Euro-American settlement of southern Minnesota, the tall-grass prairie dominated the landscape through the Minnesota River basin. A hike through our restored prairie will give us a chance to learn about some of the

plants and wildlife found in this ecosystem. Scott will talk about its benefits to the natural environment and how people over time have viewed and managed it as a resource. During the Big Woods program we will examine how these forests formed in the first place, some of the rare species found in this ecosystem and its history over time. The dense forest dominated by maple and basswood once covered a 3,000 square mile area of southern Minnesota reaching all the way to present-day Mankato. Called "Bois Grand" or "Big Woods" by early French explorers, it was recognized as a distinct area from the band of hardwood forests.
