*If we can do this on just 10% on the land in the Chippewa River Watershed, we can get way closer to the water quality standards we all desire.*

### **A FACTUAL REVIEW OF THE 1862 U.S.-DAKOTA WAR**

Learn “What we know and what we don’t know” about the U.S.–Dakota War of 1862 at a public forum Saturday, October 9, from 1:30 to 4 pm in the Community Building in Henderson, Minnesota.

The Dakota War of 1862 was the single most important event in our state’s 150-year history. In six tragic weeks more were killed than all of Minnesota’s Civil War deaths and the western half of the state was depopulated. Panelists will explore with the audience the known facts of the war, what happened at various stages and how the war was documented, and will discuss the questions still unanswered about this tumultuous time period from August to December 1862.

Forum presenters are Stephen E. Osman, military historian and long-time site manager at Historic Fort Snelling, whose slide presentation documents the causes and events of the war; Curtis A. Dahlin, an independent scholar, author and photograph historian whose focus is on the fate of those caught up in the war; and Mary H. Bakeman, historical researcher, publisher, and editor of *Minnesota’s Heritage* history journal.

The event takes place in the first floor Community Room and is free and open to the public. It will be preceded by the annual meeting of the Joseph R. Brown Heritage Society at 12:30 pm. The Joseph R. Brown Minnesota River Center on second floor will be open from 10 am to 12:30 pm.

Future forums are planned for Brown Heritage Society annual meetings in 2011 and 2012, focusing on events leading up to the U.S.–Dakota War of 1862 and the legacy of that war – how those events affected both the Dakota and the settlers. Public participation in these forums is encouraged.

### **MPCA Grant Money**

The Minnesota Pollution Control Agency today announced the availability of \$1.5 million in grant money for lake and water monitoring projects. Grants proposals are due to the MPCA by 4 p.m. on Nov. 5, 2010.

Water monitoring is often the first step toward protecting or improving water resources. Volunteers across Minnesota have been measuring the health of lakes and streams to see if the waters meet standards set for fishing and other uses since 2007 as part of a state program called Surface Water Assessment Grants. To date, the program has awarded 113 grants totaling \$5.84 million, leading to monitoring of 991 lake sites and 981 stream sites.

Eligible applicants may apply through a competitive application process. Eligible applicants include counties, soil and water conservation districts, watershed districts, water management organizations, nonprofits, Minnesota colleges and universities, and American Indian tribes. No matching or in-kind funds are required under this program.

The MPCA seeks applicants with experience in project administration, water quality monitoring and data management. The agency prefers projects that involve volunteers and that gather data for determining whether lakes and streams meet state water quality standards for aquatic life and/or aquatic recreation such as fishing. High-priority areas include the following watersheds: Cannon River, Rock River, Little Sioux River, Thief River, Sandhill River, Redeye River, Long Prairie River, Nemadji River, Lake Superior (South), Big Sioux River (Medary Creek near Pipestone)

#### **Research Microbiologist/Plant Pathologist/Geneticist (Postdoctoral Research Associate)**

The applicant will be a member of a team investigating the genetics, population biology, and host-pathogen interactions of cereal rust diseases. The project involves the application of molecular markers to the study of cereal rust diseases.

Applicant will use of virulence analysis, SSR, and other PCR based markers to study variation and gene flow in populations of *Puccinia graminis* f.sp. *avenae* and *P. coronata*; develop new genetic markers suitable for population genetic studies of *P. graminis* f.sp. *avenae* and *P. coronata*; identify QTLs for partial resistance to *P. coronata* in oat and suitable molecular markers for marker-assisted selection; develop methodologies to identify and select for partial resistance to *P. graminis* f.sp. *avenae*.
